The foundation skirt features vertical boards. The front yard is sparsely landscaped with a lawn and concrete walkway.

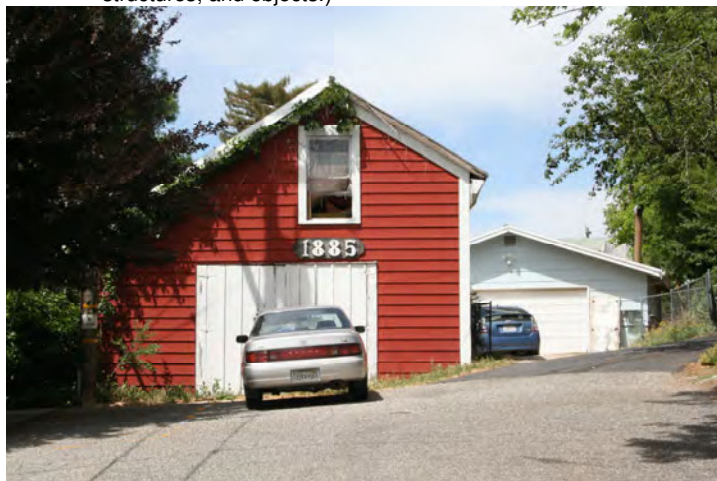

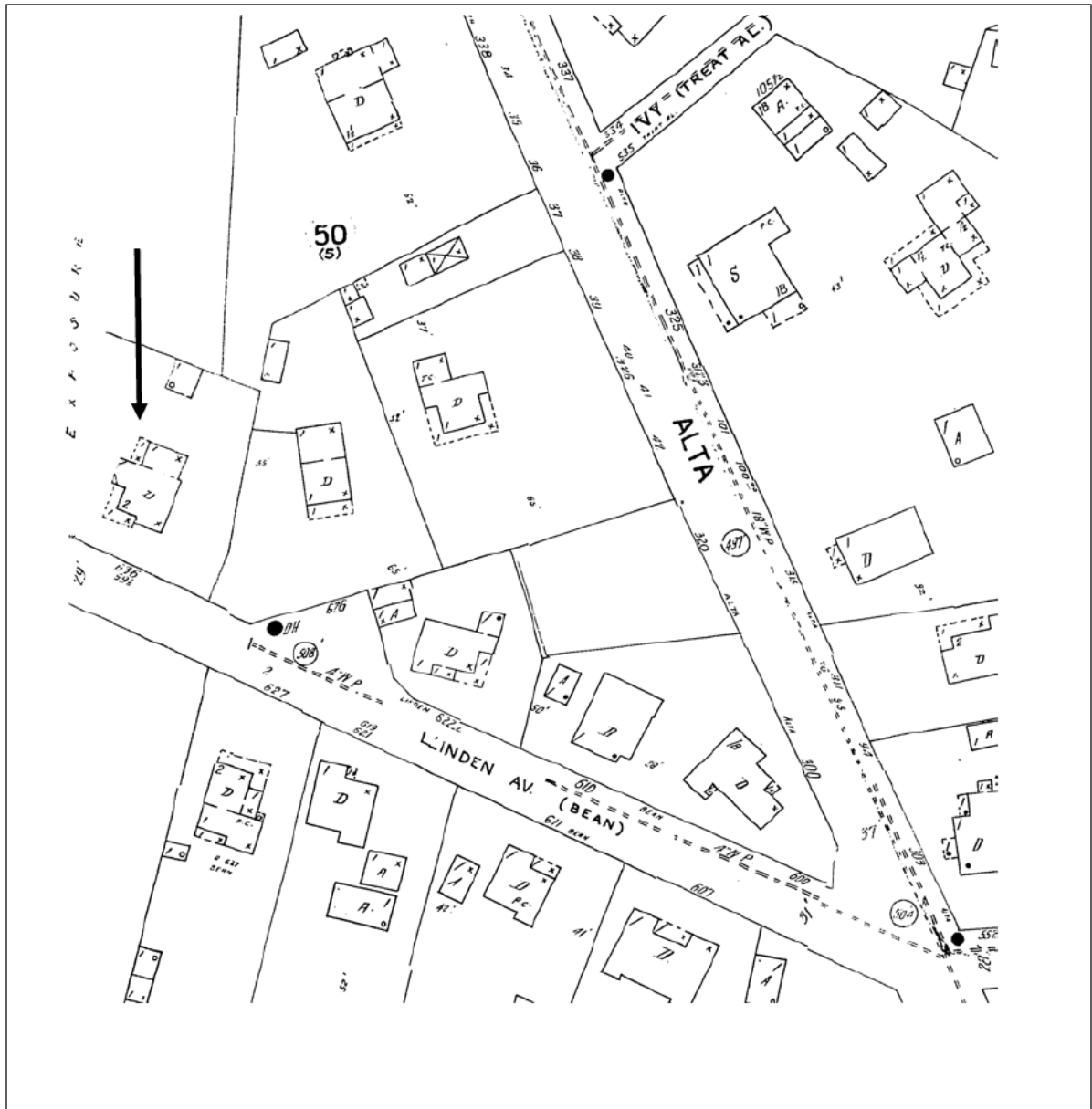

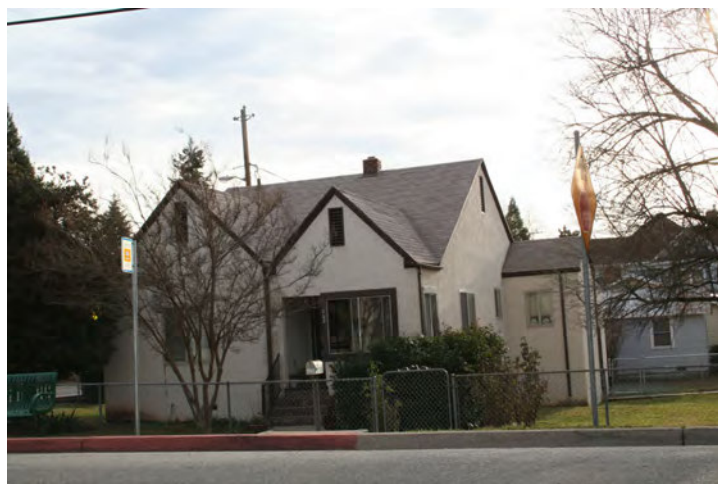
